These schedules do not include additional funding provided in the Fiscal Year 2017 budget bill for five school systems with declining enrollment (Baltimore City \$12,674,305, Calvert \$1,090,580, Carroll \$4,000,000, Garrett \$1,300,000, and Kent \$300,000). Furthermore, the amounts in these schedules do not include grants to LEAs totaling \$18,999,234 authorized, subject to budget amendment, for one-time funding for the normal cost of teacher pensions. ** Education Article Section 5-202(i) provides a grant in fiscal 2015 through 2017 to LEAs if (1) FTE enrollment in the current fiscal year is less than the prior fiscal year, and (3) "total direct education aid" in the current fiscal year is less than the prior fiscal year by more than 1%. The grant equals 50% of the decrease in total direct education aid.

The figures above do not include the following grants for LEAs with declining enrollment, budgeted for FY 2017: Baltimore City \$12,674,305, Calvert \$1,090,580, Carroll \$4,000,000, Garrett \$1,300,000, and Kent \$300,000.
