## WIP workshops planned for fall

BALTIMORE — Following a round of meetings summarizing the progress of the Watershed Implementation Plan (WIP) across the state in the spring, state agencies will hold six regional workshops this fall to help local communities address the third phase of Maryland's Watershed Implementation Plan to clean up the Chesapeake Bay.

Maryland and surrounding states are involved in a large-scale cleanup of the Chesapeake Bay. Part of the strategy requires local partners to identify solutions that reduce pollution to the Bay, under the umbrella of the state's Watershed Implementation Plan (WIP) and the U.S. Environmental Protection Agency's Total Maximum Daily Load (TMDL). Under the TMDL, pollution control measures needed to fully restore the Bay and its tidal rivers are required to be in place by 2025.

As part of the state's engagement strategy for Phase III WIP development, officials have set dates for six workshops at locations across the state. This set of fall workshops is scheduled from Nov. 15 through Dec. 5, 2018, and is intended to focus on local goals, opportunities for collaboration, and how to proceed to reach targets in 2025 and beyond.

State agencies including the Maryland Department of the Environment and the Maryland Department of Agriculture will be presenting at the workshops, which are being facilitated by the Harry R. Hughes Center for Agro-Ecology, an organization affiliated with the University of Maryland. The workshops are geared toward strengthening the working relationships between state and local entities and the nonprofit community while Maryland's WIP is implemented.

Each workshop will begin with state and region-specific overviews from the Maryland Department of the Environment and the Maryland Department of Agriculture before a set of breakout sessions organized by counties. Participants will then reconvene after lunch for a discussion on next steps.

All workshops are free and sponsored by the Harry R. Hughes Center for Agro-Ecology and funded by the Town Creek Foundation.
