

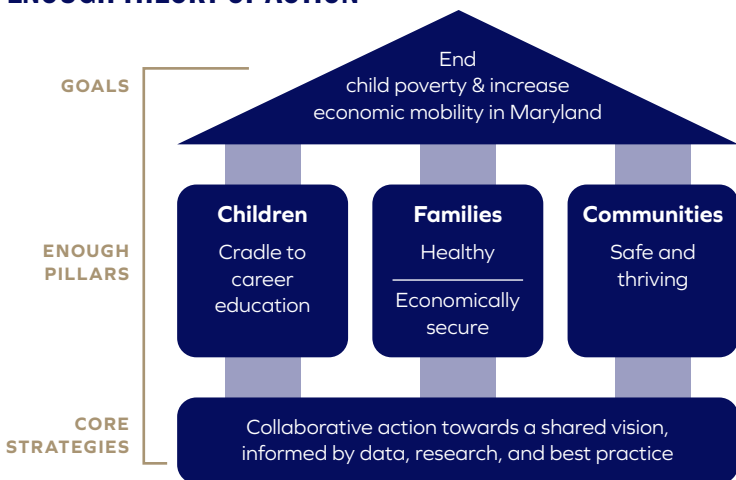


ENOUGH INITIATIVE

For too long, **concentrated, generational child poverty** has persisted in communities across the state of Maryland and denied many children the ability to fulfill their full potential and determine their own future.

The **Engaging Neighborhoods, Organizations, Unions, Governments and Households (ENOUGH)** initiative is the first-of-its-kind state-led, place-based strategy to create poverty fighting opportunities driven by communities' lived experience and expertise, data, and cross-sector partnerships. ENOUGH will surge resources into communities that have been disproportionately impacted by systems and policies that limit wealth creation and economic mobility. As Governor Moore says, **"there's a measure of intentionality that drives concentrated poverty – so there needs to be a measure of intentionality in how we're going to address it."**

FY25 ENOUGH FUNDING OPPORTUNITIES

Winning proposals will receive a mix of public and private investment. In the first year, Maryland will invest \$20 million into the ENOUGH Initiative. Program participants will also receive technical assistance as they seek additional local, state, federal, and private resources aligned with their community's vision and strategic plan.

The ENOUGH Grant Program includes (3) three tracks. Communities should review the eligibility criteria of each track to determine which aligns with their level of readiness. As communities engage in the work, they will have the opportunity to progress from one track to the next over time.

ENOUGH ELIGIBLE COMMUNITIES

To qualify for the ENOUGH Grant Program, communities must have (1) at least one U.S. Census tract where **more than 30% of children are living in poverty** AND must (2) be served by a **community school** with a concentration of poverty level of **at least 80%**. THE (3) THREE ENOUGH GRANT PROGRAM TRACKS

Track 1: Partnership Development grantees will receive a grant and technical assistance from Local Management Boards to build their capacity to address the root causes of poverty at the community level. Funded activities may include building the Community Quarterback's capacity to do place-based work, strengthening community engagement, and creating cross-sector partnerships – across education, health, workforce, housing, public safety and community development issue areas – united in the common goal of ending childhood poverty.

Track 2: Plan Development grantees will work with partners (non-profits, anchor institutions, schools, local governments, unions, philanthropy, residents, etc.) to conduct community asset mapping and needs assessments, and build a neighborhood action plan to end child poverty tailored to local needs and assets.

Track 3: Implementation grantees will launch approved neighborhood action plans, activating strategies that address the three ENOUGH pillars and engaging in ongoing progress monitoring, community engagement and continuous improvement. Grantees will also develop plans to secure and leverage additional funding streams to support their strategic vision.

ENOUGH QUALIFYING CRITERIA



MEETS COMMUNITY ELIGIBILITY CRITERIA

Communities that have at least one U.S. Census tract where more than 30% of children are living in poverty AND (2) is served by a community school with a concentration of poverty level of at least 80%



COMMUNITY QUARTERBACK

Community-led organization with resources and capacity to lead ENOUGH activities and manage ENOUGH funds, in coordination with community partners



PARTNERSHIP COLLABORATIVE

A robust partnership of community-led organizations representing each of the ENOUGH results areas

An established partnership governance structure to ensure alignment, information sharing, and resource deployment



COMMUNITY NEEDS ASSESSMENT

Completed needs assessment identifying assets and gaps, informed by community data and residents' input



NEIGHBORHOOD ACTION PLAN

An action plan that leverages various funding streams to address gaps identified in the needs assessment and provide a continuum of services for the community across ENOUGH results areas

CAPACITY BUILDING AND COMMUNITY SUPPORTS

In addition to the ENOUGH Grant Program Tracks 1–3, each Local Management Board (LMB) will receive an ENOUGH LMB Capacity Building Grant. This grant is intended to leverage the regional infrastructure LMBs provide to support local communities. While the ENOUGH Grant Program is limited to eligible communities, all counties in Maryland will receive additional resources through the LMB Capacity Building Grant.

ENOUGH Grant Program recipients will receive robust training and technical assistance support. Supports will include, but are not limited to:

- Resource hub with trainings from experts on best practices and a data dashboard to aid communities in identifying inequities, prioritizing local needs, and making data-driven decisions
- Hands-on training from local and national experts, Local Managements Boards, place-based state government staff, and other relevant state and local agencies

TRACK 1: PARTNERSHIP DEVELOPMENT (up to 10 awards; approximately \$65,000 each*)

*The actual number of awards will be based on a number of factors, including formula-driven budgets, quality of applications, and funds available.

TRACK 2: PLAN DEVELOPMENT (up to 7 awards; approximately \$300,000 each*)

*The actual number of awards will be based on a number of factors, including formula-driven budgets, quality of applications, and funds available.

TRACK 3: IMPLEMENTATION (up to 3 awards; grants up to \$5,000,000 based on community size*)

*Award is based on the number of children living in poverty in the community. Grant recipients will be eligible for four (4) cycles of funding, awarded annually. The first cycle of funding is prorated at 50% of the annual award due to a shorter cycle. In subsequent years, Implementation grantees will receive up to \$10,000,000, based on community size. The actual number of awards will be based on a number of factors, including formula-driven budgets, quality of applications, and funds available.

To apply for an ENOUGH Implementation Grant, communities must:

Track 3: Implementation grantees will implement approved neighborhood action plans, activating strategies that address the four ENOUGH results areas and engaging in ongoing progress monitoring, community engagement and continuous improvement. Grantees will also develop plans to secure and leverage additional funding streams to support their strategic vision.

ENOUGH Grant Program recipients will receive robust support. Supports will include, but are not limited to:

- Resource hub with trainings from experts on best practices and a data dashboard to aid communities in identifying assets and needs and making data-driven decisions
- Hands-on training and technical assistance from local and national experts, place-based state government staff, and relevant state agencies
